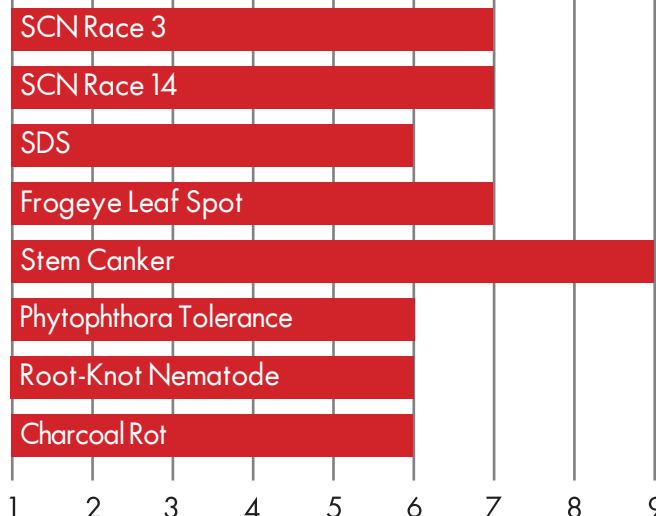

 - Rps1K = Resistant to races 1-11, 13-15, 17, 18, 21, 22, 24 & 25
 - Rps3c = Resistant to races 2-5, 8, 11-15, 18, 19, 25, 31, 32 & 35

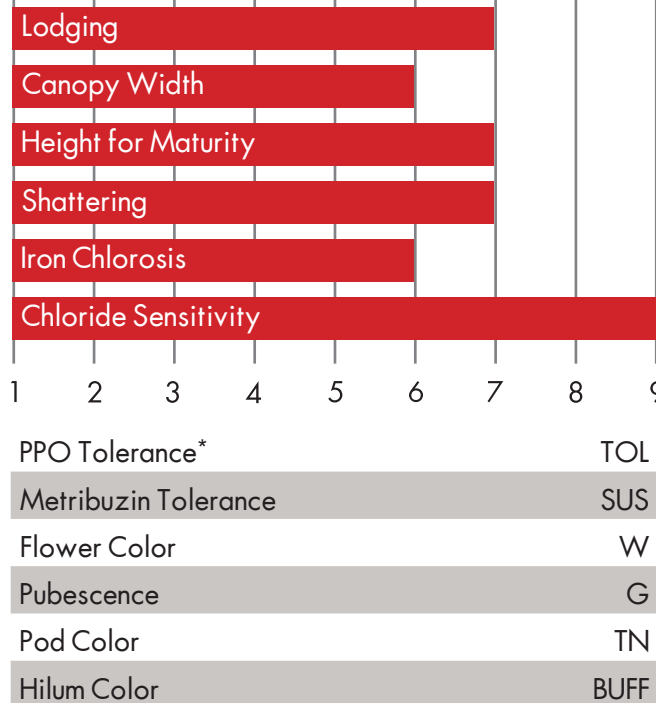
